**ABOUT THE TRAINING:** The techniques you will learn will focus on preventing explosive behavior and safely managing physical crisis. Training in these techniques will be required in order to correctly utilize "Emergency Behavior Interventions" outlined in the SELPA plan in compliance with California Code of Regulations – Title 5, Section 3000. Participants must attend both full days, and pass a written examination in order to receive certification.

**WHO:** Teachers, principals, instructional aides, psychologists, etc., who work with students with the potential for these behaviors. You must attend in teams of two, unless you will be implementing at your school with someone who has previously been trained.

**DRESS CODE:** Wear comfortable clothing and tennis shoes.  
No open toed shoes or sandals, please, or you will not be allowed to participate.
