PARTICIPANTS WILL LEARN:

- Theory and practice of behavior analysis including positive interventions.
- To conduct Functional Analysis Assessments and write reports.
- To develop Behavior Intervention Plans.
- To conduct ongoing evaluation of Behavioral Intervention Plans.
- Ventura County SELPA approved emergency intervention procedures.
- CCR regulations and procedures as implemented in the Ventura County SELPA.

This program fulfills the requirements for Ventura County SELPA Autism Certification Program Module IV (Professional Only)

In order to be certified, participants must attend all four full days, conduct a variety of assessments and develop a Functional Analysis Assessment and Behavior Intervention Plan. A written exam will be scheduled for a later date after the training.

PREREQUISITE:

Must have a strong background in positive behavioral interventions and theory of Applied Behavioral Analysis.

COST:

\$200.00 (within Ventura County SELPA); \$400.00 (outside of Ventura County SELPA), includes lunch each day and a full notebook of materials, including copies of "Behavior Interventions for Special Education Students" and "Behavior Interventions Case Managers Manual".

There is limited space available. Slots will be made available to staff from within the VC SELPA as a first priority if registration received by the deadline. Registrants from outside VC SELPA will be informed as of Oct. 6th if they will be accommodated.
